Option 1 – Flood defences from Rivergrove B&B to Coolbane Woods, except the Mall Road (Section A and Section B). Isolate the Cloon Stream from the River Shannon through raising of Island House entrance causeway and provision of a downstream cut off structure on the Cloon Stream. Provision of demountable barrier at the Scanlon Park Junction.
Option 2 - Flood defences from Rivergrove B&B to Coolbane Woods, including the full length of the Mall Road (Section A and Section B). Provision of a demountable barrier at the Island House entrance with an access and egress plan to be implemented in advance and during a flood event as appropriate.
Option 3 - Flood defences from Rivergrove B&B to Coolbane Woods, except along part of the Mall Road (Section A). Provision of a demountable barrier at the Island House entrance with an access and egress plan to be implemented in advance and during a flood event as appropriate. A raised table and embankment at the entrance to Scanlon Park including demountable barrier to the Mall Road.




